● ANNOUNCING AN E-STATEMENT UPGRADE!

In the middle of June we upgraded our E-statement system so you can view statements inside of Online Banking! No more separate password and login. Now you can do it all in one place!

Directions: Simply log-in to CB Online Banking and follow the prompts. You will see a pop-up window to enroll, and click on the accounts in which you would like to receive E-statements.

If you are not already an Online Banking customer, you will need to sign up so you can continue your E-statements. You can sign up at www.cbhutch.com. The old E-statement login will be kept on the site for two months, then be taken down.

We apologize for this inconvenience, but are confident you will enjoy the benefits of the new system, which will allow a longer history of statements to review, in addition to saving paper and time over traditional paper statements.
