Get a grip on your Debit Card transactions, thanks to Shazam BOLT\$

with even greater security measures! Now, you can set blocks for three transaction types:

- Transactions over a specific dollar amount
- Internet and phone transactions
- Transactions outside the U.S.

If a block is in place, transactions will be declined on the spot. You will receive an alert each time an attempted transaction is blocked.

Make sure you download the Shazam BOLT\$ app, a free download for CB Debit Card holders. It is available for most smart phones.
