ALERT: GRANDPARENT SCAMS



There has been a recent surge of grandparent scams in our area. Be aware of these typical fraud scenarios:

- A grandparent receives a phone call (or sometimes an email) from a "grandchild." Usually the person claims to be in a bad situation, like being arrested or getting into a car accident and needs money ASAP. The caller doesn't want his or her parents told.
- Sometimes, instead of the "grandchild" making the phone call, the criminal pretends to be an arresting police officer, a lawyer, a doctor, etc.

How to recognize scammers:

- PRETEND to be a police officer.
- Says there's a **PROBLEM** to cause worry.
- PRESSURE you to act immediately.
- Tell you to **PAY** a specific way, usually with a gift card, prepaid debit card or cash.

Protect yourself and be skeptical of a contact you did not initiate. Always remain calm and contact someone you trust.
